



## Seller Agreement & Policy

By enrolling as a seller ("Seller"), you agree to the following terms with Ready Tap Save, LLC ("RTS"), a New York limited liability company.

---

### 1. Eligibility & Status

Sellers must be 18+ or represent a verified fundraising organization. Minors may assist under adult supervision through registered nonprofits or fundraising organizations. Sellers are independent contractors, not employees, and are responsible for taxes and legal compliance. RTS may request documents to verify fundraising legitimacy.

---

### 2. Compensation

Sellers earn \$8 per qualifying first-time coupon pass sale using their assigned code. No commissions are paid on renewals, refunds, chargebacks, or self-purchases. Payouts are issued via ACH between the 1st–5th of each month for the previous month.

---

### 3. Adjustments & Fees

RTS may adjust seller payouts with 30 days' notice. Failed ACH payouts may incur a \$25 fee, deducted from future earnings per payout attempt.

---

### 4. Dashboard & Discrepancies

The seller dashboard is user-generated and unofficial. Official earnings reports are emailed monthly. Discrepancies must be reported within 10 days.

---

### 5. Customer Renewals

Buyers agree to 12-month automatic renewals at the current rate. Sellers are only compensated for initial sales made with their code.

---

### 6. Code Integrity

Seller codes are non-transferable and cannot be shared, reused, posted online, or used for self-purchase.

---

## **7. Marketing Conduct**

Sellers may not:

- Post false claims, spam, or misleading promotions
- Violate laws, trespass, or harass
- Use logos, photos, or branding of any participating business without written permission

This includes:

- Creating or sharing unauthorized materials with merchant branding
- Misrepresenting business partnerships
- Filming or photographing inside locations without consent

Violations may result in account termination, forfeited commissions, and legal action. Sellers may only use official marketing materials provided by RTS.

---

## **8. Withholding & Termination**

RTS may withhold payouts or suspend seller accounts for misuse, fraud, or breach of this agreement.

---

## **9. Non-Transferability**

Seller accounts and codes may not be sold or reassigned without written approval.

---

## **10. Earnings Disclaimer**

RTS makes no guarantees of seller income. Earnings depend on the seller's effort and outreach.

---

## **11. Modifications**

This agreement may be updated at any time. Continued participation indicates acceptance of changes.

---

## **12. Tax Obligations**

Sellers are responsible for tax reporting. A 1099-NEC will be issued for annual earnings of \$600+.

---

**13. Liability & Risk**

Sellers assume all responsibility for personal promotion. RTS is not liable for incidents, injuries, or legal issues during sales efforts. Door-to-door solicitation is not permitted.

---

**14. Dispute Resolution**

Disputes will be resolved via arbitration or small claims court in Broome County, NY under New York law.
